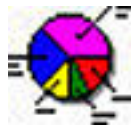

“Managed some nice flounder today. The big one is 18.5 inches and 2 3/4 lbs! the others are just 13 and 12 inches big. My partner got a nice 15 inch and some smaller ones too. All at the Quogue canal. East End B&T took the weights and info for the Fisherman. I'm mailing you the weigh slip they made me.” Carlee Ogeka

"I caught this Spanish Mackerel along with a load of spotted sea trout, ladyfish and a couple of strange saltwater catfish that will shock you if you don't handle them properly. It's a real thrill to fish in this shallow water as black tipped sharks and rays swim by. The cold weather earlier this week in Florida really put the fishing down until the flats warmed up as warm weather set in. Fishing in 3 feet of water with live bait and a float is something that can probably be used on out flats around East and West Fire Island for weakfish. This and a lot of quiet might just do the trick. We'll find out soon enough. Caught this guy in the photo on Wednesday, March 29. He weighed 3 pounds even and put up a great fight on light spinning tackle." John Caruso
